NEW PHYSICIAN SUPERVISOR/PHYSICIAN ASSISTANT RATIOS FOR MEDICALLY UNDERSERVED AREAS

Recent legislative changes (see SB 1950 below) allow physicians who work in medically underserved areas to supervise up to four physician assistants. Please call the Physician Assistant Committee office at (916) 561-8780 for information concerning this program.

NEW LAWS

AB 269 (Correa, Chapter 107, Statutes of 2002)

This bill states that the highest priority of the Physician Assistant Committee in performing its licensing, regulatory, and disciplinary functions is the protection of the public. This same language was enacted for the other boards, commissions and bureaus within the Department of Consumer Affairs.

SB 1301 (Kuehl, Chapter 385, Statutes of 2002)

This legislation enacts a new Reproductive Privacy Act which provides that "it is the public policy of the State of California that: a) every individual has the fundamental right to choose or refuse birth control; b) every woman has the fundamental right to choose to bear a child or to choose and to obtain an abortion, except as specifically limited by this article, and c) the State shall not deny or interfere with a woman's fundamental right to choose to bear a child or to choose to obtain an abortion, except as specifically permitted by this article.

Provisions of this bill also subject a person to penalties for the unlawful practice of medicine if he or she performs or assists in performing a nonsurgical abortion, and at the time of so doing does not have a valid, unrevoked, and unsuspended license to practice as a physician and surgeon, or does not have another valid, unrevoked, and unsuspended license or certificate that authorizes him or her to perform or assist in performing the functions necessary for a nonsurgical abortion.

This legislation also defines "nonsurgical abortion" as including termination of pregnancy through the use of pharmacological agents.

SB 1558 (Figueroa, Chapter 263, Statutes of 2002)

This bill authorizes a certified nurse midwife, a nurse practitioner, and a physician assistant to sign for the request

and receipt of complimentary drug and dangerous devices samples that have been identified in the standard procedure, protocol, or practice agreement approved by a physician. No provision of this bill is intended to expand the scope of practice of a certified nurse midwife, nurse practitioner, or physician assistant.

SB 1950 (Figueroa, Chapter 1085, Statutes of 2002)

This bill:

- Extends the date on which the Physician Assistant Committee would become inoperative to July 1, 2007 and repealed to January 1, 2008.
- Increases the number of physician assistants that a physician supervisor providing services in a medically underserved area can supervise from two to four
- Grants the Physician Assistant Committee the authority to issue a probationary license to an applicant for licensure as a physician assistant.

SB 2019 (Speier, Chapter 683, Statutes of 2002)

This bill authorizes a licensing board or agency to cite and fine a health care practitioner if the practitioner is in default on any U.S. Health Services education loan. In determining the amount of a fine or whether to issue a citation, the board must consider the population served by the health care practitioner and the health care practitioner's economic status.

This bill also requires the board that issues citations and fines to retain the money from those fines for deposit into its appropriate account.
